You are currently reporting false, inaccurate, misleading, and libelous information about me which I demand that you immediately correct concerning the unlawful detainer identified. Your failure to (1) **fully investigate** this dispute, (2) remove the false data from your records and reporting scheme, (3) report your error to all recipients of your false information within the past 3 years and (4) to confirm its removal to me in writing **within 30 days** as required by Civil Code Section 1786.24 will result in my filing a civil action against The U.D.Registry, Inc, and all other persons responsible, pursuant to Civil Code Sections 1786.20(d) and 1786.50, in addition to other causes of action, for actual and statutory damages of **no less than \$35,000 per person** affected, attorney fees, court costs, interest, and punitive damages related to the wealth of the corporation and those responsible for its operation.

You are further notified that extensions of time will not be permitted based upon your claims of insufficient information, nor because the form you *prefer* was not used. A court will have to decide whether you had sufficient information to make the required inquiry and correction. If you should conclude that my dispute is frivolous or irrelevant, the action will still be filed against you, and the court will have to decide whether your decision was proper, in light of all the circumstances.
